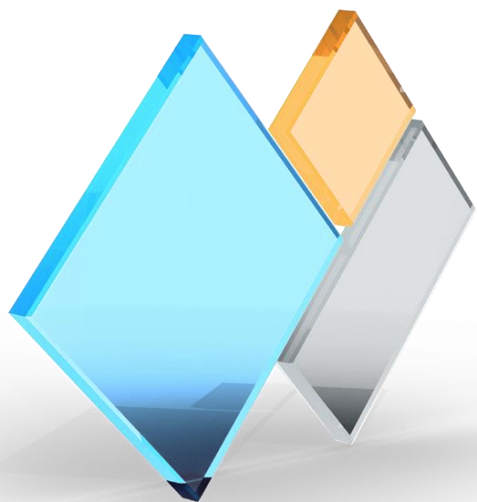

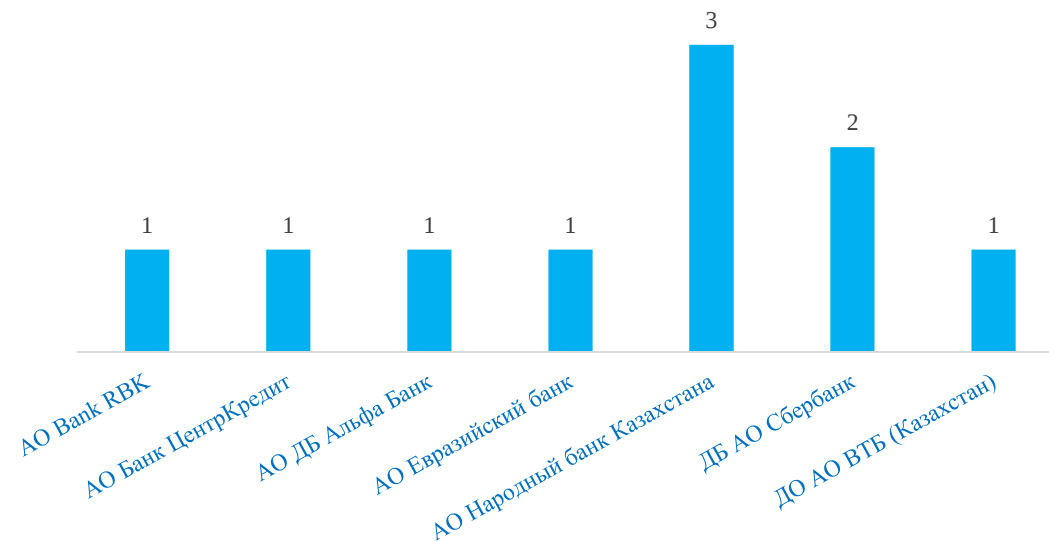

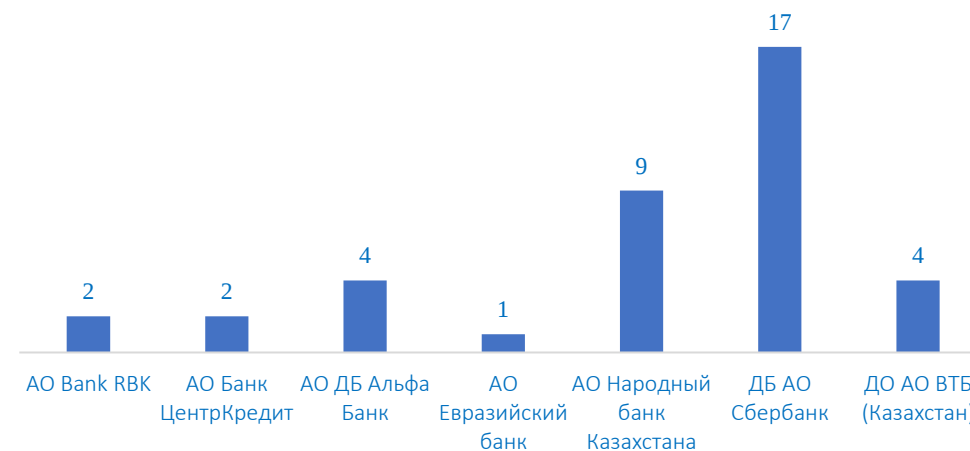

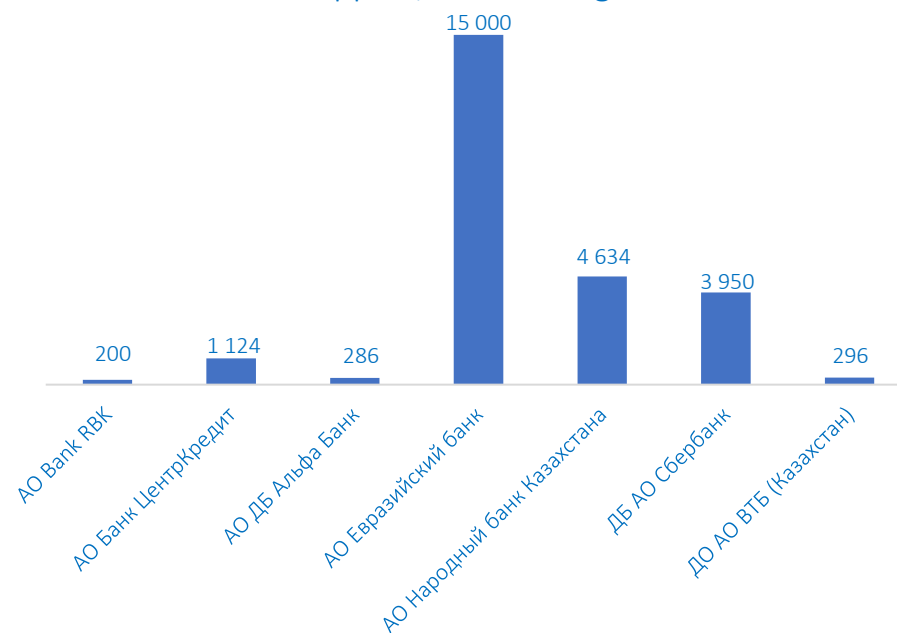
Number of signed insurance contracts

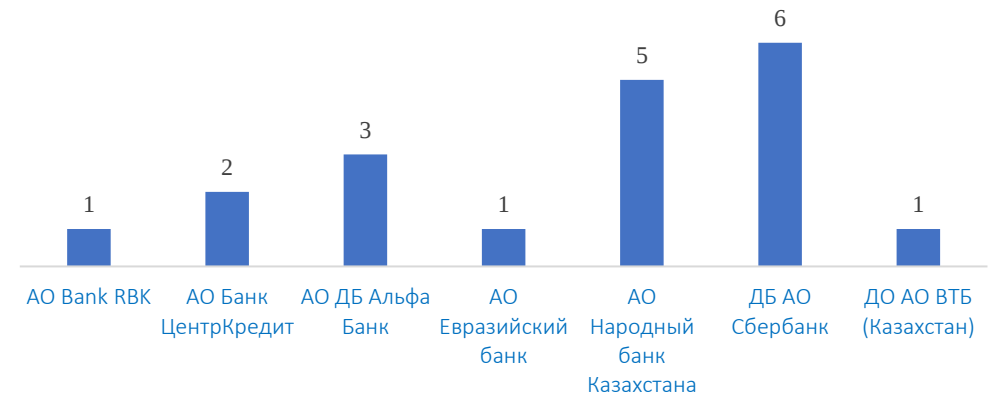
The total amount of financial and insurance support, million tenge
