# ENVIRONMENTAL CODE OF THE REPUBLIC OF KAZAKHSTAN



- ◆ On July 1, 2021, the new Environmental Code of the Republic of Kazakhstan (hereinafter referred to as the Code) came into force, laying the transition foundation to technological regulation in environmental protection - regulation based on the best available techniques (BAT), resource-saving technologies and practices, volume reduction and lowering the level of generated waste's hazard and its effective management, the use of renewable energy sources, water conservation, as well as the implementation of measures to improve energy efficiency, sustainable use, restoration and reproduction of natural resources.

- ◆ The application of the BAT is aimed at comprehensive prevention of environmental pollution, minimizing and controlling negative anthropogenic impacts on the environment, and increasing resource efficiency.



# ENVIRONMENTAL CODE OF THE REPUBLIC OF KAZAKHSTAN



KAZAKHEXPORT



One of the objectives of the environmental legislation of the Republic of Kazakhstan is a state encourage and stimulation to attract “green” investments and the widespread use of the BAT.

In accordance with the Environmental Code, the implementation of the BAT is not affected for existing facilities commissioned before July 1, 2021. At the same time, they have the right to implement the BAT on a voluntary basis.

When reconstructing/modernizing existing facilities, as well as for newly commissioned enterprises of category 1 (facilities that have a significant negative impact on the environment), it is a mandatory requirement from January 1, 2025.



Information on the implementation of the BAT and the BAT reference books can be studied on the International Center for Green Technologies and Investment Projects NCJSC website (created by Decree of the Government of the Republic of Kazakhstan dated April 27, 2018 ).

In order to stimulate the introduction and application of the BAT, Article 577 of the Code of the Republic of Kazakhstan On taxes and other obligatory payments to the budget provides economic incentives for taxpayers that help increase the profit and competitiveness of the Company, ensuring the stability of the cost of products.
